Privacy Policy Statement

MORE MINUTES COMMUNICATIONS S.L. store all your Personal Data in electronic databases with absolute confidentiality (Law 15.1999) which databases are located on servers and computers in our headquarters in Spain, at Avenida de la Industria n° 4, edificio. 3, esc. 2, bajo, 28108 Alcobendas, Madrid, accordingly with the requirements of the existing legislation in Spain (subsequently, the "File of Personal Data"). The existence of this Personal Data File database is communicated to the Data Protection Agency in Spain.

Use of Personal Data

Internal Use
